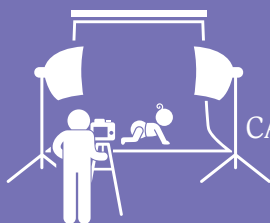

Dear High Risk Hope Family,

Thanks to your support, 2018 was a year of unprecedented growth for High Risk Hope (HRH). We added two new hospital partners, piloted two new programs and expanded our reach beyond Florida and California with our newly developed HRH Bundles. None of this would have been possible without the \$470,000 of donations and in-kind gifts given this year.

In 2018, the HRH family grew to include AdventHealth Tampa and Mease Countryside Hospital where we supported 155 additional Tampa area families, expanding our total number of families impacted this year to 1,950. HRH also piloted two new programs, monthly NICU Dinners and Bereavement Boxes, at St. Joseph's Women's Hospital, both of which received praise from benefitting families. HRH hopes to expand these vital programs to our other hospitals in 2019.

Perhaps the most exciting developments for HRH in 2018 are the new Bed Rest Bundles and NICU Baby Bundles. As the only nonprofit in the nation that supports families before and after a premature birth, for years we have sought to develop a sustainable plan to reach the thousands of families outside our current geographic area who need our support. Items in the Bundles include those that families say bring the most hope and inspiration. This year, HRH supported 56 families in Indianapolis with Bundles and our aim is to continue expanding to hospitals around the country as they are easily shipped.

As the country's premature birth rate continues to rise, HRH aims to impact not only the premature birth rate, but also the overall mental health of families experiencing the trauma of a high-risk pregnancy and premature birth. Your continued support helps us strive toward our goal to reach every woman and family needing our programs. Thank you for your loyalty and for truly making a difference in the lives of thousands of families each year.

Jersey Mike's Subs Month of Giving

2018 Giving Days

HRH Baby Calendar

The fifth annual HRH Calendar Baby contest was a huge success! 56 babies entered, and over 104,000 votes were tallied to select the HRH babies featured in this year's calendar which will be delivered to over 2,000 families in 2019.



Tot Trot

HRH's sixth annual Tot Trot presented by Jersey Mike's Subs was held in November during Prematurity Awareness Month. A record number of 900+ Tot Trotters walked, ran, and strolled down the Miracle Mile, helping to raise over \$90,000.



Bundles in Indianapolis

HRH's Bed Rest Bundle and NICU Baby Bundle programs were designed with the ultimate goal of encouraging families both before and after the birth of a premature infant. Hospitals, clinics, and other organizations have the option to order HRH Bundles in bulk and/or sign up for regular subscriptions. This year, Indianapolis resident, Emily Collins, became the first person to bring HRH Bundles to Franciscan Health Indianapolis.




New Programs

HRH added two new programs in 2018, NICU Dinners and Bereavement Boxes. Both programs were piloted at St. Joseph's Women's Hospital. NICU Dinners provide an environment for NICU families to connect. We collaborated with HRH mom and volunteer, Angie Bresnahan, to thoughtfully curate each item found in our Bereavement Box.

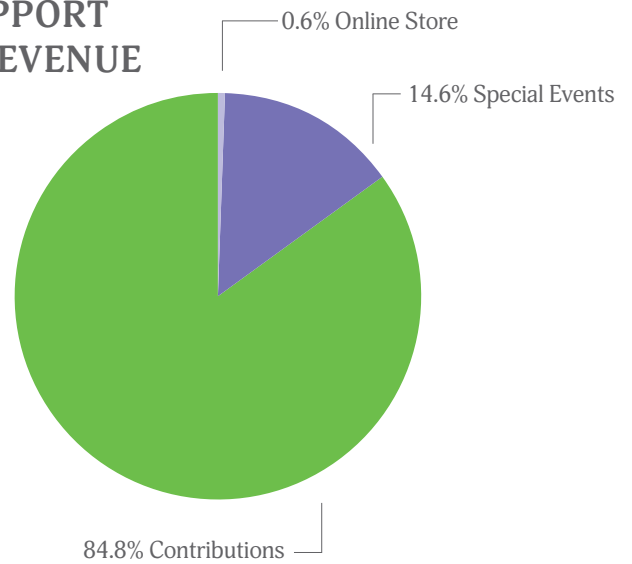

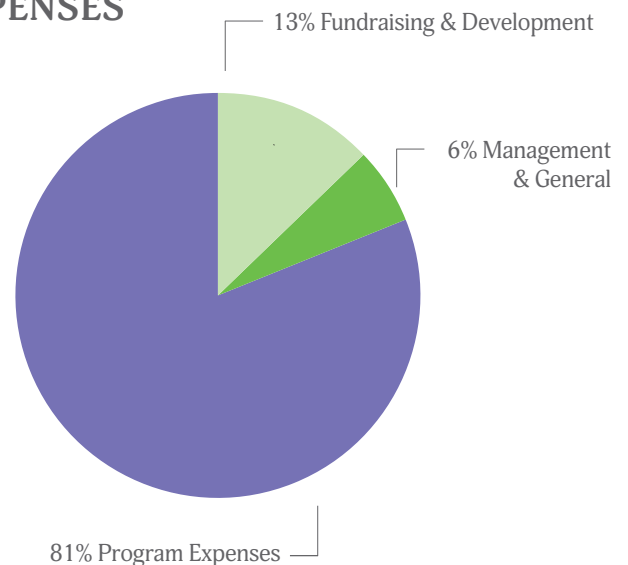

She is a true ray of sunshine! Born on June 21, 2017, the summer solstice, "Maggie" loves to be outside and frequently closes her eyes and turns her face towards the sun. She enjoys flashing her gums at strangers, waving to passers-by in Publix, and eating anything she can get her dimpled hands on. During her month-long stay at St. Joseph's Women's Hospital, there were many difficult days and weeks, but the delicate care she received and the tenderness of her nurses warmed our hearts and will never be forgotten by our family. In four weeks she learned to breathe on her own, was weaned off her feeding tube, made some "sick gains" in the weight department, and was treated for jaundice. Bringing a premature baby into the world is simultaneously precious and heartbreaking, but with everyday miracles worked by hospitals like St. Joe's and the kindness of groups like High Risk Hope, what a difference a year can make.

For the first several days of Magnolia's life we could not hold her, and for the majority of her month-long stay we were given just 20 minutes a day for skin-to-skin contact. The joy of meeting your child is a beacon of hope unlike any other, but when it seems you can do nothing but "hope" for your ill child, it can be a very helpless feeling. The book in High Risk Hope's NICU Napsack gave us a way to comfort our child with our voices when we could do nothing for her physically. It empowered us to care for her in creative ways, and we turned the windowsill in her hospital room into a bookshelf, bringing in more books from home to read to her each day. When times are hard, as they often are in the NICU, every small gesture of kindness helps you make it through the next minute, of the next hour, of the next day. Thank you for lighting a candle High Risk Hope.
